Restoration Projects

Side Channel Restoration:



In collaboration with Native Fish Society, we helped to improve habitat in an important side channel of the Molalla River. The side channel provides refuge to young salmon & trout when the Molalla mainstem temperatures get too hot and reach lethal limits. The side channel remains cool and is an important refuge for temperature sensitive fish. Large wood was added to alter flow, allow water to spill over the wood, and help create more pool habitats that are important to fish.



Elks Park:

Molalla River Watch coordinated with the park manager at Elks Park in Mulino to help plant 180 trees with scout troop 257 near the eroding bank on the Molalla River. It was our last in-person event before COVID-19 restrictions.



Restoration Projects



Molalla River State Park:

Molalla River Watch and Oregon Parks & Recreation Department finished up prerestoration project planning at Molalla River State Park, which has over 400 acres in floodplain habitat and is located at the confluence of the Molalla, Pudding, & Willamette Rivers.

Pre-restoration project planning revealed new information:

- Molalla River State Park is home to lamprey & freshwater mussels! Future restoration work will avoid disturbing juvenile lamprey & freshwater mussel beds now that we know their locations.
- During rainy season high water periods, water from the Willamette backwaters up the Molalla River. So, the floodplain around the mouth of the Molalla also acts as a floodplain to the Willamette River.
- Invasive knotweed occupies more of the State Park than we realized. Over 25 acres of invasive knotweed were treated in preparation for future native planting.

Funders included Oregon Watershed Enhancement Board, Bonneville Power Administration, and Willamette Water Supply Program.

On-Going Partnerships

Molalla River Drinking Water Project

We continue to participate in the National Water Quality Initiative project initiated by Clackamas Soil & Water Conservation District focused on drinking water sourced from the Molalla River. The project assesses potential impacts to drinking water quality. Did you know that Molalla, Colton, & Canby get their drinking water from the Molalla R Watershed? We serve as Technical Advisory Committee members & meet regularly. They are also taking community input at <u>https://</u> <u>molallariverdrinkingwater.com/</u>



Amphibian Egg Mass Surveys at Aquila Vista

Conducted our 6th year of amphibian egg mass surveys. We found 654 northern red-legged frog & 16 northwestern salamander egg masses!
